## **DISTRIBUTOR'S WARRANTY**

Honda Canada Inc., for and on behalf of Honda Motor Co. Ltd., Tokyo, Japan, gives the following written warranties on each new Honda SXS/MUV manufactured by the manufacturing facilities controlled by Honda Motor Co. Ltd., distributed in Canada by Honda Canada Inc. and sold by an authorized Honda SXS/MUV dealer.

(Whenever used herein, the word "Honda" refers to Honda Canada Inc. and/or Honda Motor Co. Ltd. as appropriate from the context.)

HONDA WARRANTS THAT each new SXS/MUV will, under normal use and maintenance, be free from any defects in material or workmanship for the terms as outlined below:

This warranty begins on the date the SXS/MUV is delivered to the first retail purchaser or the date it is first placed in service as a demonstrator, lease or company SXS/MUV.

If any defects should be found in an SXS/MUV within the respective periods stated on this page, necessary repairs and/or replacement with a new Honda part or the Honda equivalent shall be made at no cost to you for parts or labour, when Honda acknowledges that such defects are attributable to faulty material or workmanship at the time of manufacture.

**Exceptions to this warranty are noted on the following pages under Seat Belt, Tire and Emissions Warranties.**

## **THE WARRANTY COVERS**

- a) Any Honda SXS/MUV purchased in Canada from an authorized Honda SXS/MUV dealer which has been registered at the time of purchase on a form provided by Honda, which has had set-up and pre-delivery service performed by an authorized Honda SXS/MUV dealer and which is normally operated in Canada
  
- b) Any factory installed part except normal maintenance parts referred to in “THE WARRANTIES OUTLINED DO NOT COVER”.
  
- c) Any Honda SXS/MUV on which required maintenance services have been performed as prescribed in the Owner’s Manual.

## SEAT BELT WARRANTY

Honda Canada Inc. will repair or replace at its option, any Honda SXS/MUV seat belt component that fails to function properly during normal use. This includes all parts and labour.

This warranty's coverage begins on the same date as the new SXS/MUV Warranty, and continues for 5 years unlimited distance.

This warranty does not cover replacement of a properly functioning seat belt assembly strictly for cosmetic reasons, and failure caused by abuse, alteration, accidental damage, misuse, or malfunction resulting from a collision.

## TIRE WARRANTY

Tires originally installed on new Honda SXS/MUVs are warranted by their manufacturer and **NOT** by Honda. If an original tire on your SXS/MUV has a defect in material or workmanship, please contact your tire manufacturer or ask your Honda SXS/MUV dealer for assistance.

## **EMISSION CONTROL SYSTEMS WARRANTY**

All Honda SXS/MUVs are designed and built to comply with all applicable Canadian federal emissions standards in effect at the time of manufacture. Any defects in materials or workmanship which would cause non-compliance within the periods stated below will be repaired or replaced at no cost for parts and labour.

Emission components of the SXS/MUV engines are warranted for 30 months (2½ years) unlimited distance.

This warranty begins on the date the SXS/MUV is delivered to the first retail purchaser or the date it is first placed in service as a demonstrator, lease or company SXS/MUV.

## WARRANTY COVERAGE

Emission components of the Honda SXS/MUV engines are covered by this warranty for a period of 30 months (2½ years), from the date of delivery to the first retail purchaser. This warranty is transferred to each subsequent purchaser for the duration of the warranty period.

Warranty repairs will be made without charge for diagnosis, parts, and labour. All defective parts replaced under this warranty become the property of Honda Canada Inc. A list of warranted parts appears at the end of this section. Normal maintenance items, such as spark plugs and filters, that are on the warranted parts list are warranted up to their first required replacement interval only.

Only Honda approved replacement parts will be used in the performance of any warranty repairs and they will be provided without any charge to the owner. The use of replacement parts not equivalent to the original parts may impair the effectiveness of your engine's emission control system. If such a replacement part is used in the repair or maintenance of your engine, and an authorized Honda SXS/MUV dealer determines it is defective or causes a failure of a warranted part, your claim for your engine may be denied. If the part in question is not related to the reason that your engine requires repair, your claim will not be denied.



## PARTS COVERED BY THE EMISSIONS CONTROL SYSTEMS WARRANTY

SYSTEM	PARTS DESCRIPTION
<b>Fuel Metering System</b>	Throttle body (including throttle position sensor), fuel injector, fuel pump, fuel pressure regulator, manifold absolute pressure sensor, engine oil temperature sensor, starting enrichment thermal valve, starting enrichment valve, intake manifold, idle air control valve, and fuel filter*.
<b>Ignition</b>	Ignition coils, ignition control module, engine control module, cam position sensor, knock sensor, spark plugs*, spark plug cap, spark plug wires, engine coolant temperature sensor, gear position switch, crankshaft position sensor, distributor ignition capacitor, vehicle speed sensor, and BARO sensor.
<b>Air Injection System</b>	Pulse secondary air injection check valve, pulse secondary air injection control valve, and pulse secondary air injection solenoid valve.
<b>Air Shot System</b>	Intake air shot air valve, and intake air shot air check valve.
<b>Exhaust System</b>	Exhaust manifold, catalytic converter, oxygen sensor, heated oxygen sensor, exhaust gas control valve, exhaust pipes (to catalyst and between catalysts), and air fuel ratio sensor.

<b>Intake Air Temperature System</b>	Intake air temperature valve, air intake temperature check valve, air intake temperature sensor, and air intake temperature thermal vacuum valve.
<b>Evaporative Emission Control System</b>	Fuel tank, and fuel fill cap.
<b>Crankcase Emission Control System</b>	Air cleaner housing, air cleaner element*, oil filler cap, air cleaner housing cover, PCV valve, PCV control solenoid valve, crankcase breather separator, crankcase breather storage tank, and crankcase breather tube plug.
<b>Miscellaneous Parts</b>	FI indicator light bulb, malfunction indicator light bulb, tubing, fittings, seals, gaskets, hoses, clamps, and mounting hardware associated with these systems.

## **EXCLUSIONS**

FAILURES OTHER THAN THOSE RESULTING FROM DEFECTS IN MATERIAL OR WORKMANSHIP ARE NOT COVERED BY THIS WARRANTY. THIS WARRANTY DOES NOT EXTEND TO EMISSION CONTROL SYSTEMS OR PARTS WHICH ARE AFFECTED OR DAMAGED BY OWNER ABUSE, NEGLIGENCE, IMPROPER MAINTENANCE, MISUSE, MISFUELLING, IMPROPER STORAGE, ACCIDENT AND/OR COLLISION, THE INCORPORATION OF, OR USE OF, UNSUITABLE ATTACHMENTS, OR THE UNAUTHORIZED ALTERATION OF ANY PART.

THIS WARRANTY DOES NOT COVER REPLACEMENT OF EXPENDABLE MAINTENANCE ITEMS MADE IN CONNECTION WITH REQUIRED MAINTENANCE SERVICE AFTER THE ITEM'S FIRST SCHEDULED REPLACEMENT AS LISTED IN THE MAINTENANCE SECTION OF THE PRODUCT OWNER'S MANUAL, SUCH AS SPARK PLUGS AND FILTERS.

## **GENUINE HONDA REPLACEMENT PARTS WARRANTY**

This warranty guarantees that Genuine Honda replacement parts purchased by you will be free from defects in material or workmanship for the following periods:

Replacement Parts                      1 Year

Genuine Honda parts repaired or replaced under this warranty are covered for the remainder of the specified warranty period of the purchased part.

If any defects are found and reported to a dealer within the respective period, and Honda acknowledges that such defects are attributable to faulty material or workmanship at time of original manufacture, the necessary repairs or replacements will be made at no cost to you. If the part was installed by anyone other than a Honda SXS/MUV dealer, it will be repaired or replaced without charge for the part, but you must pay the labour.

### **This Warranty Does Not Cover**

- the color match of components (Honda Canada makes no warranty, express or implied, regarding the color match of components).

The above exclusion applies specifically to replacement parts, in addition to the exclusions shown on pages 12-14.

## **GENUINE HONDA ACCESSORIES**

This warranty guarantees that Genuine Honda Accessories purchased by you will be free from defects in material or workmanship for a period of one (1) year.

Coverage begins on the date of purchase from an authorized Honda Canada SXS/MUV Dealer.

Genuine Honda accessories repaired or replaced under this warranty are covered for the remainder of the specified warranty period of the purchased part.

Honda Canada Inc. will repair or replace, at its option, any Honda Genuine Accessory that is defective in material or workmanship under normal use.

To qualify for this warranty, the Honda Genuine Accessory

- must have been purchased from an authorized Honda SXS/MUV dealer.
- must have been used in an application for which it was designed.

If the part was installed by anyone other than a Honda dealer, it will be repaired or replaced without charge for the part, but you must pay the removal and installation charges.

## **THE WARRANTIES OUTLINED DO NOT COVER**

- a) A unit being used for other than the designated intention.
- b) Any repairs required as a result of a collision, vandalism, accident, neglect, racing, misuse or lack of required maintenance, or the use of leaded gasoline.
- c) Any repairs required as a result of remodeling or modifications made to accommodate or install any accessories, attachments, parts or devices which have not been tested and approved by Honda.
- d) Any unit on which the odometer or emission control systems have been altered, modified or remodeled and rendered inoperative or the true distance travelled cannot be determined.
- e) Any warranty repair (other than emission control systems) not diagnosed, and/or performed by an authorized Honda SXS/MUV dealer.
- f) Deterioration due to normal wear or exposure.

- g) Units, which for any reason have been declared a total loss or sold for salvage purposes.
- h) Units which have been repaired with parts not made or supplied by Honda and that part is responsible for the failure or malfunction.
- i) Paint matching. Honda Canada Inc. reserves the right to decide whether painting the repaired or replaced part to match the original finish is practical. Honda Canada Inc. will not under any circumstances pay for painting the entire unit solely for paint matching.
- j) Normal maintenance services and adjustments such as, but not limited to the following; wheel balance and alignment, brake and clutch adjustment, tightening of nuts, bolts and fittings, engine tune-up, headlight alignment, and the replacement of parts made in connection with normal maintenance services including filters, gaskets, spark plugs and wires, fuses, clutch and brake linings, belts, coolants, drive chain, cables, lubricants, hoses and other expendables susceptible to natural wear.
- k) To the extent the law permits, Honda disclaims any responsibility for loss of time or use of the SXS/MUV, transportation or towing cost (except as described in this booklet) and any other indirect, incidental or consequential damages, inconveniences or commercial loss.

- l) Parts or accessories affected or damaged by:
- normal wear
  - improper maintenance
  - theft
  - fire
  - lack of required maintenance
  - accident and/or collision
  - the unauthorized alteration of any part
  - the incorporation or use of unsuitable attachments or parts
  - unsuitable use in an application for which the part was not designed
  - deterioration from the elements
  - neglect
  - vandalism
  - improper installation
  - misuse
  - abuse

## **THE OWNER'S OBLIGATION**

In order to maintain the validity of this DISTRIBUTOR'S WARRANTY, the required maintenance services as set forth in the Owner's Manual must be performed at the proper intervals and detailed receipts and records retained as proof.

## **TO OBTAIN WARRANTY SERVICE**

You must take your SXS/MUV, at your expense, during normal service hours to any authorized Honda SXS/MUV dealer across Canada. If you are unable to obtain or are dissatisfied with the warranty service you receive, take the following steps: first contact the owner of the dealership involved; this should resolve the problem. No dealer or his agent or employee is authorized to extend or enlarge on this warranty on behalf of Honda by any written or verbal statement or advertisement (except through a Honda Plus extended warranty contract).

To the extent the law permits, Honda disclaims any responsibility for loss of time or use of the SXS/MUV, transportation or towing costs or any other indirect, incidental or consequential damage, inconvenience or commercial loss.

## **PRIVACY STATEMENT**

## **NOTICE TO CUSTOMER**

The provisions contained in this written warranty are not intended to limit, modify, take away from, disclaim or exclude any warranties set forth in the operation of The Consumer Products Warranties Act, 1977 (Saskatchewan), the Consumer Protection Act (Quebec), or any other similar provincial or federal legislation.

Your authorized Honda dealer has assembled and prepared your new Honda SXS/MUV to ensure that all systems and components are operating according to manufacturer's specifications.

As part of the delivery of your new Honda SXS/MUV your dealer has explained maintenance requirements, operations and warranty conditions assuring that you received all standard items including your owner's manual, warranty policy and owner registration form.

Please present your copy of the Owner Registration to your dealer's service department when service or warranty repairs are required.

## **HONDA PLUS**

If you plan to drive your new SXS/MUV for a longer period of time or a higher number of kilometres than covered by the Honda warranties mentioned, Honda Plus will be of interest to you.
